Foundation Announces \$2.75 Million Investment in Accion



In an effort to increase economic empowerment and improve the health of communities with the highest needs across Colorado, the Foundation recently provided \$2.75 million in support to [Accion](#), a community development finance institution that offers microfinancing and small-business loans to populations that can face barriers to entrepreneurship. Over the past decade, the organization has distributed nearly \$35 million in loans to 1,841 small businesses in Colorado, with an estimated 4,310 jobs created or sustained by the organization's client businesses statewide.

The total \$2.75 million is provided through a \$1.75 million [program-related investment \(PRI\)](#) as lending capital, as well as a \$1 million program grant. The PRI will help to scale Accion's Colorado-based lending activities, with a focus on serving entrepreneurs of color and individuals with low-to-moderate income. The grant will be used to support the organization's operations and outreach in targeted rural communities beyond the Front Range.

Research has linked improved economic stability to better health outcomes over time. Working to increase employment opportunities for communities and enhance financial conditions for individuals and families is critical to achieving health equity. By providing fair and flexible loans to those often overlooked by traditional financial providers, Accion seeks to boost economic stability across Colorado. In turn, a growth in economic stability has the potential to generate greater access to housing, fresh food, health insurance and preventive care for more Coloradans. The senior program officer will provide leadership and oversight for on-the-ground execution of the Foundation's strategies in affordable housing and children's physical activity.

Qualified candidates will have proven expertise in establishing and nurturing relationships with strategic partners (i.e., other foundations, nonprofits, governmental agencies and key decision-makers). They will also have a broad and deep understanding of the social determinants

of health (e.g., poverty, housing, food, etc.) and health philanthropy. Experience working in the health sector is a plus, as is experience working in philanthropy or the nonprofit sector. Candidates must possess a bachelor's degree.

Foundation Commends Pilot Program by FCC to Promote Telehealth for Low-income Coloradans



On Sept. 10, the Foundation [submitted a letter](#) to the Federal Communications Commission (FCC) regarding the agency's announcement of a new pilot program to expand broadband-enabled telehealth services to individuals and families experiencing low income. The FCC solicited public comment on several aspects of their proposed program, including program structure, health focus areas, approach to measuring improved outcomes and more. In its comment letter, the Foundation applauded the FCC's decision and offered direct feedback on many of the structural and operational questions related to its proposed [Connected Care Pilot Program](#).

The growth of telehealth services has proved promising when it comes to decreasing barriers and increasing access to high-quality comprehensive health care. This is especially true for populations that traditionally struggle with accessing care, such as older adults, veterans and residents of rural or low-income communities. By taking advantage of high-speed broadband connectivity, we have the opportunity to bring down the cost of care and expand delivery options for health care providers; and broaden the reach and accessibility of quality care to more Coloradans.
