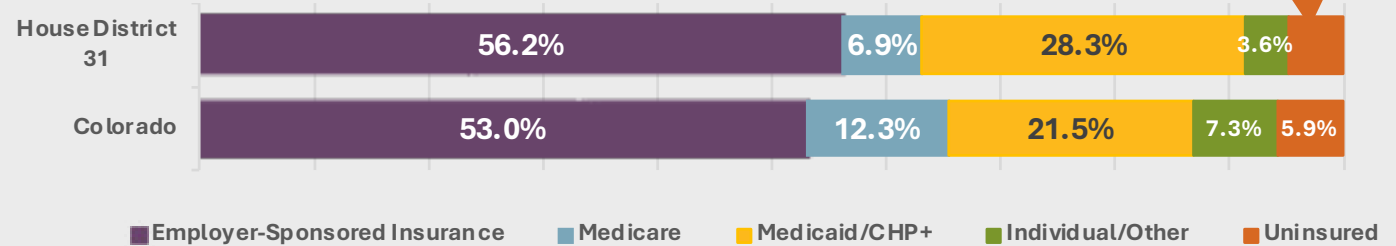

## Health Insurance

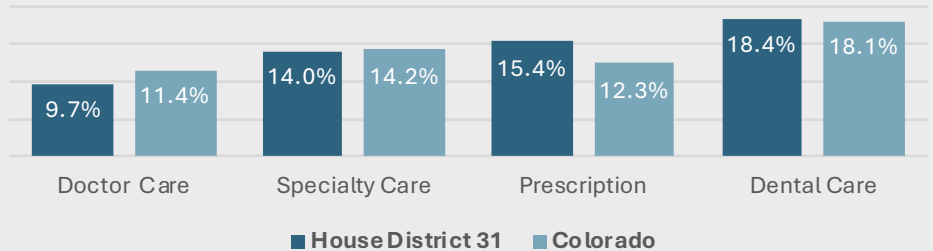
Medicaid membership is higher than the Colorado rate in this district.

## Barriers to Health Care

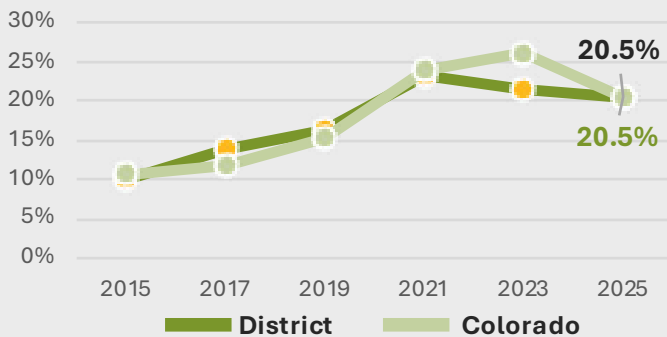
**9.7%** of people in this district could not get doctor care they needed in 2025.

of people in this district had trouble paying for medical care, housing, or food in 2025.

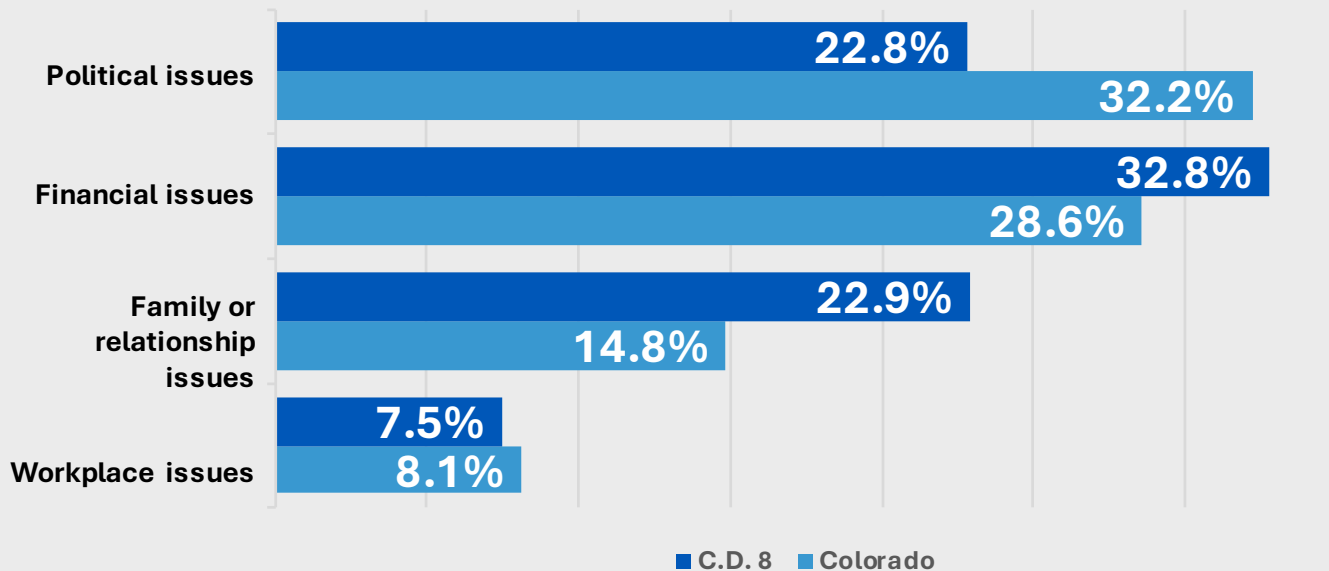

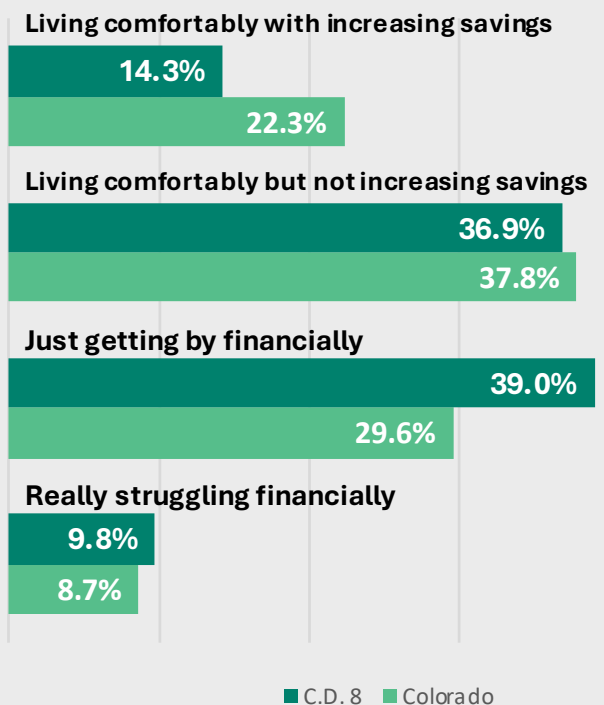
# Congressional District 8

## Economic Well-Being

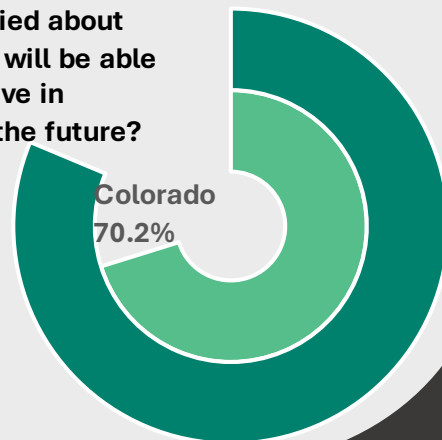


### In order to pay the rent or mortgage:

# Context of Federal Funding for Your Constituents

Actions taken by the federal government through the passage of H.R. 1 will have significant impacts on the lives of Coloradans. This timeline is shared to inform decisions made by Colorado policymakers.

# 2025

**JULY**

▶ **H.R. 1 passes.**

Immediate effect was a loss of \$1.2 billion in state tax revenue.

**OCTOBER**

▶ **SNAP work requirements expanded to include adults 55 to 64, parents with children 14 to 17.**

- Refugees and asylees no longer eligible for SNAP.
- SNAP Education grant terminated, eliminating \$6 million in annual funding to nutrition education programs in Colorado.

**AUGUST**

▶ **Colorado governor calls special session, resulting in \$250 million in cuts to health, housing, and higher education.**

**DECEMBER**

▶ **Federal government grants Colorado \$200 million through the new Rural Provider Relief fund. Rural hospitals, clinics, and other health providers will be eligible to apply for this funding.**

**JANUARY**

▶ **Enhanced subsidies end for people purchasing insurance through Connect for Health Colorado.**

▶ **Federal government freezes about \$300 million in Colorado for child care subsidies, Temporary Assistance for Needy Families, and the Social Services Block Grant. The state sues to reverse this decision.**

# 2026

**OCTOBER**

▶ **About 7,000 immigrants barred from Medicaid, including refugees, asylees, humanitarian parolees, and trafficking survivors.**

▶ **SNAP funding cuts begin.**

State and counties must pay an extra \$50 million for administrative costs.

# 2027

**JANUARY**

▶ **Medicaid work requirements begin for about 380,000 Coloradans.**

Eligibility checks increase to twice a year, instead of annually.

**OCTOBER**

▶ **Cuts begin for Medicaid's Hospital Provider Fee.**

Colorado could lose \$900 million to \$2.5 billion annually by 2032.

▶ **Federal government stops paying full cost of SNAP food benefits.**

States must pay up to 15%, based on their payment error rates.
